## **PARTICIPANT AGREEMENT, WAIVER, RELEASE, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

**WARNING:** READ THIS ENTIRE AGREEMENT CAREFULLY BEFORE SIGNING, AND INITIAL BESIDE EACH PARAGRAPH AS YOU READ IT! BY SIGNING THIS AGREEMENT, YOU GIVE UP THE RIGHT TO SUE IN THE UNITED STATES FOR ANY INJURY, ILLNESS, DEATH, OR DAMAGE CAUSED BY ANYTHING THAT HAPPENS ON THE GUIDED HUNTING TRIP, OR THAT IS CONNECTED IN ANYWAY TO HORTEMILLER BLUETICKS.

In consideration of the services of Hortemiller Blueticks, Brian Hortemiller and his agents, owners, volunteers, participants, employees, guides, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "Hortemiller Blueticks"), I hereby freely, knowingly, voluntarily, and intentionally agree to release, indemnify, and discharge Hortemiller Blueticks, on behalf of myself, my spouse, my children, my parents, my next of kin, and my heirs, assigns, personal representative, and estate as a precondition to entering into a guided hunting trip and related activities, as follows:

\_\_\_\_\_ **1.** I acknowledge and understand that my participation in a guided hunting trip involves inherent risks, known and unanticipated, that may cause injury, illness, and possible death to myself, or to third parties, and damage to my property. I understand that such risks, foreseen and unforeseen, are inherent in a guided hunting trip and activities related thereto, and cannot be completely eliminated without jeopardizing the essential qualities of the activity.

\_\_\_\_\_ **2.** I understand and agree that by signing this Agreement, I am giving up all of my rights to sue or claim against Hortemiller Blueticks.

\_\_\_\_\_ **3.** I acknowledge that I am aware of the potential risks, hazards, and dangers incidental to a guided hunting trip, including but not limited to risks, hazards, and dangers arising out of or connected to any of the following:

uneven or rough terrain, including boggy terrain; traveling via automobile, or other means of conveyance; the use of ropes, harnesses, and equipment; forces of nature, including lightning, harsh and inclement weather, and sudden temperature changes; exposure to insect bites; cold, including hypothermia and frostbite; water (whether moving or not, both above and below ground), including drowning; natural and man-made hazards; rock falls; unstable surface or subsurface conditions; possible attacks or mauling by domestic or wild animals; domestic or wild animals that may be diseased or otherwise potentially dangerous; failure, malfunction, or loss of equipment (including firearms and other weapons); handling, use, and discharge of firearms and weapons; poisonous snakes, insects, and spiders; blinds, tree stands, and bait stations, whether or not erected by Hortemiller Blueticks; injury, accident, illness or death caused by other hunters.

I acknowledge that a guided hunting trip and all related activities are dangerous and involve the risk of injury, illness, death, and property damage, including but not limited to the risks set forth above, and I expressly accept and assume full responsibility for the same entirely at my own risk. My participation in this activity is purely voluntary, and I elect to participate in spite of the known and unknown risks associated with it.

I hereby voluntarily waive, release, and forever discharge, on behalf of myself, my spouse, my children, my parents, my next of kin, and my heirs, assigns, personal representative, and estate, all claims, demands, actions, causes of action, or suits of law or in equity against Hortemiller Blueticks that may arise out of or be related to the guided hunting trip, and all activities related thereto, that I participate in, including bodily injury, illness, death, or property damage, including the compounding or exacerbation of any injuries sustained, whether caused by the negligence of Hortemiller Blueticks or otherwise. I further agree to indemnify and save and hold harmless Hortemiller Blueticks from any and all losses, liability, damages, costs, or expenses, including legal and/or attorneys' fees, it may incur as a result of any lawsuit I initiate, or any lawsuit initiated on my behalf.

I understand that it will be in the interest of my safety to listen to and abide by any instructions or advice provided by Hortemiller Blueticks, but that following such instructions or advice will not necessarily protect me from the inherent dangers associated with a guided hunting trip and all activities related thereto, and will not in any way invalidate any part of this Agreement.
